RESULT FOR E-VOTING PROCESS – APPOINTMENT OF AUTHORISED REPRESENTATIVES

Pursuant to the Notice dated October 22, 2025 for reconstitution of the Stakeholders' Consultation Committee ("SCC") please note that the SCC has been reconstituted the basis of the List of Stakeholders dated October 15, 2025, as published on the website of Go Airlines (India) Limited ("**Corporate Debtor**"),.

Based on the List of Stakeholders, the Liquidator facilitated the E-voting process for the nomination of Authorised Representatives (ARs) to the SCC for Employees as well as other Operational Creditors. The E-voting process commenced on **Wednesday, October 29, 2025** and concluded on **Monday, November 3, 2025 at 5:00 PM**. Pursuant to the conclusion of the E-voting process, the process of nomination of ARs has now been completed.

Based on the votes received, the following have been duly appointed as Authorised Representatives to the reconstituted SCC:
